Cover image: The figure on the cover (from Miranda-Carús et al, page 2791) illustrates annexin V and propidium iodide staining of synovial fibroblasts in which apoptosis has been induced by treatment with an anti-TRAIL R2 (DR5) antibody. The induction of fibroblast apoptosis by an agonist anti-D5 antibody indicates that this protein is functionally active on this cell type and could be a target of novel therapy.
