**Cover image:** The figure on the cover (from Flores-Borja et al, page 293) shows a representative example of colocalization of Lyn with lipid rafts in a healthy subject. B lymphocytes were fixed and stained for lipid rafts (red) and Lyn (green) and analyzed by confocal microscopy for staining patterns and areas of colocalization (yellow). Colocalization was semiquantified by determining the proportion of green pixels colocalizing with red pixels.
